Mr May was appointed as a director of International Consolidated Minerals Limited ("IMC") on 8^{th} December 2008. An Administrator was appointed to IMC on 18 August 2009, IMC remains in a process of Administration. The estimated deficit to creditors is £33.4m, including an intercompany claim of £18.7m. The original Administrators are being sued by the current Administrators for the sale of assets at under value, which is contested. The latter have until 17th August 2015 to conclude matters.
